This waiver and release is for individuals who attend the PBS39 MicroBrew Festival to be held at Coca-Cola Park, Allentown. It may not be modified. In consideration of being allowed to attend and participate in any way in the PBS39 MicroBrew Festival and related activities, the undersigned acknowledges, appreciates and willingly agrees that:

1. I acknowledge and fully understand that participation in the PBS39 MicroBrew Festival involves inherent risks including but not limited to: (a) Intoxication from the alcohol I consume;(b) The possibility of bodily injury including but not limited to broken bones, soft tissue damage, and damage caused by negligent acts of myself or others; (c) The risks associated with traveling to any destination after the Event, especially the risks of operating a motor vehicle after consuming alcohol. I knowingly and freely assume all such risks, both known and unknown, even those arising from the negligent acts or omissions of myself or others, and assume all responsibility for my participation.

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, and agree to save and hold harmless Lehigh Valley Public Telecommunications Corporation, PBS39 Foundation Corporation and WLVT RE, Inc.
